We're on the move again! We left London Wall Buildings at the end of June and found temporary accommodation on Cornhill in the City of London but now need to find somewhere longer. We are busy packing up to move mid-December and hoping to finalise a new lease in the next few weeks that will give us a longer tenure and a more secure base from which to grow our fantastic charity. We are trying to continue being located in, or on the edges of, the City. One option is to find sites that will soon be redeveloped, and which can be let to a charity on non-commercial terms, pending the start of the works. Our contacts and supporters are very kindly helping us to find potential properties.

Over the last six months we have been extremely busy helping our clients look their very best for job interviews and the world of work. Our clients include young people just starting off in life, perhaps being interviewed for an apprenticeship or their very first job. We have a developing partnership with the National House Project, helping young people in care to build friendships and networks of support. Our young clients from the National House Project travel to us from all over England and Wales and we help with interview outfits, formal wear and that all-important feeling of confidence and support.

We fit out all our clients in a suit and give them the confidence that they need to succeed. Unity Works, one of our referral agencies, recently commented, 'Biggest thanks goes to Suited & Booted whose kindness and support towards people with LDDA has been invaluable and their work allows us to support greater independent living and real-world opportunities for our clients.'

We're lucky to have a brilliant team of volunteers and everyone plays their part – stylists, wardrobe assistants, reception, logistics, admin support and shoe buyers – the help that we get is phenomenal and our volunteers are the bedrock of Suited & Booted. Meet the Volunteers – David Smith

Hello, my name is David and I am a volunteer with Suited & Booted. I am a Registered Nurse who has been working with children and young people with mental health and behavioural problems for the



last 41 years; I retired a few years ago although I still like to keep my hand in and now work part-time which has freed me up to do other things.

I have been volunteering at Suited & Booted for nearly 8 years and I volunteer one day a week. I heard about Suited & Booted by reading an article in The Observer and then a few weeks later I heard Maria (Lenn, charity founder) talking on BBC Radio London and took this as a sign to make contact.

There is so much to do at Suited & Booted and I have had a go at all roles in my 8 years with the charity. I started off working in the wardrobe where donations are sorted, to working with clients and getting them ready for their interview or new job by styling them; most days I will see and style 5 or 6 clients. Getting a client into their interview clothing is the most rewarding aspect of the work and all volunteers play a part in that and it is always good to see the difference in someone

once they are suited & booted; the difference is not only physical and there is often a newfound confidence in many clients.

I live in Surrey with my husband and I have two grown up children; one lives in Paris and the other is getting ready to move to New York. I love to travel and I have been to France four times this year and had a trip to Latvia and now having children living abroad gives me more reason to travel.
